Provide accurate event details, including guest count and venue access information.

Ensure timely payment of fees as agreed.

Provide access to the venue for set-up, service, and clean-up.

LIABILITY

The Caterer shall not be held liable for any damages, losses, or injuries resulting from causes beyond their control, including but not limited to acts of God, power failures, or venue restrictions. The Client agrees to indemnify and hold harmless the Caterer against any claims arising from the event.
