Ensure that all food is prepared, handled, and served in compliance with local health and safety regulations.

Provide all necessary serving equipment, utensils, and staff as agreed.

The Client shall:

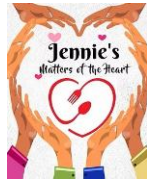
Provide accurate event details, including guest count and venue access information.

Ensure timely payment of fees as agreed.

Provide access to the venue for set-up, service, and clean-up.
